- ii. Accounts and records of General accounts, Women of the Church, Education committee, Memorial fund, and Improvement fund were audited
- iii. Some notes they had were:

7. Pastor's Report

- a. February of 2023 Pastor hosted a council retreat with the goal that we would all land on the same page and decide what to work on in 2023
 - i. The focus was healthy congregations and healthy communication at the retreat
 - ii. At the retreat the council committed ourselves to working together more closely and keep open and healthy communication skills going
 - iii. We also chose not to overlook or ignore conflicts and to try to deal with them as they arise in a timely and healthy manner

- This commitment was put to the test throughout the year as a few conflicts arose & we tried to use what we learned in February at the retreat to deal with the conflicts
- b. Pastor worked at her goal of figuring out who is still a member at Our Redeemer's
 - i. We had a large list with people who had not attended in a long time
 - ii. Through letters, phone calls, and conversations Pastor was able to paint a clearer picture of who is currently on the active member rolls of Our Redeemer's
- c. Held a class for serving communion to shut ins in November with 2 people attending the training
 - i. If anyone else is interested, please let Pastor know at any time
- d. Pastor's call is still 3⁄4 time and she does work elsewhere
 - i. One day a week is spent at Festival Foods and another 1-2 days are spent at Ferguson Family YMCA of Green Bay
 - 1. This gives her variety and lots of chances to interact with people throughout her week

 - 2. Roy Lawrenz motioned and Ken Holmes seconded to accept the Building, Maintenance, and Improvement committee's motion; Ballot vote passed 32 yes votes to 0 no votes

c. Constitution & Policy

- i. Announcement: Motion by the Constitution Policy and Procedure Committee and the Church Council have proposed a change to an amendment that has been budgeted for. Currently the treasurer and financial secretary are not required to be elected to the church council to carry out their duties.
- The changes come from pages 12 and 13 of the Constitution under "officers." The amendment would be in section D adding the council secretary to the treasurer and financial secretary.
- iii. The change would say, "If the church council secretary, treasurer, and/or financial secretary are not selected from the elected membership of the Church Council, the council secretary, treasurer, financial secretary shall have voice, but not vote at the meetings of the Church Council."
- iv. This proposal will be voted upon on March 3, 2024 at a special congregational meeting following the worship service.
- v. Discussion followed that led to the possibility of needing to edit some of the wording because the council secretary holds a seat on the executive board of council. There may need to be a representative elected from council to serve on the board along with the President and Vice President.
