 - 1. Roy Lawrenz made a motion to accept the agenda as printed, seconded by Erika Schindel; the motion was passed unanimously.
- D. Review, (revise), and accept meeting notes from the Council meeting on 10 September 2024.
 - 1. A motion was made by Erika Schindel and seconded by Earl Macha to accept the notes from the Council meeting on 10 September 2024, as printed. The motion was passed unanimously.
- E. Approval of the financial reports (until audited).
 - 1. General fund

 - 5. A motion was made by Erika Schindel and seconded by Roy Lawrenz to accept the financial reports of the General, Improvement, Memorial, and Blessing Basket funds, as presented, until audited. The motion was passed unanimously.

- F. President's report Karen Zahn
 - 1. Budget requests are needed for planning next year's Congregation budget. Email copies of the budget requests should be sent to the Office Secretary by 8 November.
- G. Pastor's report Pastor Beth Macha.
 - 1. A written report was provided.
 - 2. The pet blessing service held on 15 September received very good reviews.
 - 3. It was clarified that all quarterly reports should be sent electronically to the Office Secretary.
- H. Reports of Committees That Have Met Recently.
 - 1. Blessing Basket.
 - i. The financial report was received and accepted.
 - 2. Building and Improvement/HVAC Sub-committee.
 - i. A written report was provided.
 - ii. The BMI Committee made a motion to hire Vans, our current HVAC vendor, to replace two pumps which supply heating and cooling for the sanctuary. The motion was seconded by Ericka Schindel, the motion passed unanimously.
 - 3. Constitution and Policy
 - i. A motion was made by Roy Lawrenz and seconded by Greg Stabbe to approve a change in the process, called The Electric Notification Policy, to notify members of the Congregation of meeting schedules and to describe this policy in the bylaws and glossary (initially approved by the Congregation at the May 2024 quarterly meeting).  - ii. Ericka Schindel will set up the Giving Tree program for the Congregation before the Christmas season.
 - iii. Nancy Macha will check on the Thrivent matching funds for the Congregation's contribution to ELCA's disaster relief fund.
